

## **Bouncy Castle Hire Safety Instructions and Disclaimer**

# **User Safety Instructions**

- 1. Height Restrictions: To ensure safety, we have specific height restrictions for users:
  - Maximum users at 1m (3.3 feet): 6
  - Maximum users at 1.2m (4feet): 5
  - Maximum users at 1.5m (4.9 feet): 4
  - Maximum users at 1.8m (5.9 feet) and above: 4

#### 2. Prohibition of Food and Drinks:

• No food, drinks, or gum are allowed on or near the Bouncy Castle to prevent choking and damage (Please take note that if the Bouncy Castle is returned in a soiled or damaged condition, the person hiring it will incur a cleaning and/or repairing charge).

## 3. Attire and Accessories:

 All participants must remove footwear, glasses, jewellery, and badges before using the Bouncy Castle.

### 4. Unsafe Activities:

• Climbing, hanging, or sitting on walls is extremely dangerous and under no circumstances should this be allowed.

# 5. Supervision:

A responsible adult must always provide continuous supervision for the Bouncy Castle.
The consumption of alcohol or any other substances is forbidden while using or supervising the Bouncy Castle.

### 6. Crowd Control:

• Ensure that the Bouncy Castle is not overcrowded and limit the number of participants according to their age and size. Try to prevent large and small participants from using it simultaneously.

### 7. Preventing Unsafe Behaviour:

 Please discourage participants from engaging in horseplay, pushing, colliding, fighting, or any behaviour likely to injure or distress others. Somersaults are strictly forbidden, as they are highly dangerous on this type of equipment.

### 8. Front Safety Step:

 Do not allow anyone to bounce on the front safety step, as a participant could easily bounce off the inflatable and get hurt. The step is intended to assist users in getting on or off safely.

#### 9. Health Precautions:

• It is essential to ensure that no one with a history of back or neck problems, brittle bones, or pregnant women are allowed on the Bouncy Castle, as well as any participant who is feeling unwell.

### 10. Inflation and Deflation Safety:

• Do not allow anyone to be on the Bouncy Castle during inflation or deflation as this is dangerous.

## 11. Forbidden Items:

Keep toys, or sharp instruments away from or near the Bouncy Castle

### 12. Blower Malfunction:

• In the event of the blower stopping working, please ensure that all users immediately exit the inflatable. Please inform us immediately.

# 13. Silly String:

 No silly string is to be used on or near the Bouncy Castle, as it causes permanent staining, and the hirer will be expected to cover the cost of replacing the equipment in the event of silly string being used on or near the inflatable, causing staining.

The individual, organisation, or entity hiring this inflatable equipment will be held responsible and liable for any damage or injury resulting from misuse or reckless use.
